College Alumni Elect Fourth Consecutive Petition Trustee

For the fourth time in the last four elections of alumni-selected seats on the Dartmouth College Board of Trustees, a conservative petition candidate has been elected. The winner, Stephen Smith '88, benefited from a constitutionally prescribed election system that divides the votes of mainstream alumni. That system requires a committee of the Alumni Council to nominate three candidates for each Board vacancy, thus causing mainstream votes to be dispersed across the field. The system also uses the "approval method" of voting, whereby each voter can vote for as many candidates as that voter deems qualified. Under this system, Smith received 9,984 votes of 32,941 total votes cast; however, Smith received a vote from 54 percent of the 18,186 alums who voted, a percentage

PRIDE REIGNS ON CAMPUS

The Dartmouth Gay Straight Alliance hosted Dartmouth's first-ever PRIDE Week from May 7th to 11th this year. The weeklong event was intended to raise awareness about the LGBT community's experiences today and throughout Dartmouth's history. DGALA alums participated extensively in the event, and DGALA also provided significant

not matched by any other candidate. DGALA had urged its members to support all of the three Council-nominated candidates. The Dartmouth College Board of Trustees is an 18-member body, eight of which are selected by the alumni. Four of those eight now have been elected by conservative alumni. About 28 percent of alumni voted in the election. An effort last fall to amend the Alumni Council Constitution to, among other things, permit head-to-head contests between Council-nominated and petition-nominated candidates failed to receive the required two-thirds vote for passage.

Smith's campaign was controversial even by standards of recent alumni elections. Early in his campaign Smith asserted that free speech was suppressed at Dartmouth, pointing mainly to the College's disciplining of a fraternity whose members had printed sexually demeaning comments about female undergraduates. In general, Smith painted a negative picture of Dartmouth, causing President James Wright publicly to object that the main factual premises of Smith's campaign were false and to assert that the campaign was harmful to the College. *The Dartmouth*, in an editorial published after the election, stated that it was "disheartened" by Smith's election. The student paper noted particularly that, in this first trustee campaign in which private expenditures were permitted, Smith's campaign had benefited from very substantial financial and other tangible support from sources that he refused to identify. DGALA President Susi Kandel '00 stated that DGALA was extremely disappointed by Smith's election, noting the importance of vigilance by Dartmouth's LGBT community, lest recent gains be lost. Professor Peter Saccio expressed just such sentiments last week, noting the importance of the

College's trustees in setting policies that impact LGBT students. (See article, page 1.) In his report from the Alumni Council below, DGALA representative David Eichman '82 expresses similar concerns and hints at a possible solution. ♦

DGALA ALUMNI COUNCIL REP REPORTS ON COUNCIL MEETING IN WAKE OF TRUSTEE VOTE

The Dartmouth Alumni Council allocates one seat to each of the five Affiliated Groups, including DGALA. David Eichman '82 is DGALA's current representative to the Council. The Council held its semi-annual meeting at the College on May 17-19, 2007, and David makes this report to DGALA:

The Alumni Council members at their recent meeting were very concerned about perceptions, procedures and the outcome of the recent alumni election. It is clear from comments of alums during the election that most alums do not understand the purpose of the Alumni Council and more importantly, do not realize that the Alumni Council is an organization that is separate and apart from the College and is not run nor directed by the College. In the last several trustee elections, petition candidates have gained a lot of votes by claiming that all Alumni Council members are "insiders" who are directed by President Wright and the administration. This is an outright lie and part of a campaign of misinformation that is used to campaign against Alumni Council-nominated candidates. The Alumni Council and especially the Nominating Committee of the Alumni Council (which is required by the current constitution to nominate 3 candidates for each vacancy) believes that is will be virtually impossible to find qualified candidates who will be willing to run under the current system. It seems clear that unless you are able to come up with hundreds of thousands of dollars for a trustee election campaign, you do not have a chance to win under the current system. I am saddened to think that a man who has not been involved with the College since his graduation in 1988, has never volunteered with any alumni organization and has not contributed a penny to the College is still able to get elected to our Board of Trustees. The Alumni Council is willing to work with the new leadership of the Association of Alumni to come up with solutions to the existing problems which "game" the system in favor of a petition candidate. Ultimately, the Board of Trustees will need to decide the best method for making sure that the best candidates are appointed to the Board of Trustees if it indeed wants Dartmouth College to remain the best college in the world. ♦

The week's events included a wide array of activities and events, including a CookOUT outside the Collis student center, coming out stories, free confidential HIV testing, evening lectures by DGALA members Keith Boykin '87 and Joanne Hermann '75, a concert that benefited a poor village in Kenya beset by AIDS, and a fabulous Gala Dinner and LGBTQA Awards Ceremony held in the main dining room of the Hanover Inn and on the Inn's terrace overlooking the Green.

Dinner Celebrates Past and Present

Some 150 students, alums, faculty and staff attended the Friday night dinner and awards ceremony at the Hanover Inn, which kicked off with drinks and hors d'oeuvres on the terrace at which the guests were treated to a preview of an in-progress student-made documentary film about LGBT history and current life at Dartmouth. After a fine dinner in the Inn's Daniel Webster dining room, the GSA, Pam Misener (Assistant Dean and Advisor to LGBT Students), keynote Speaker Professor Peter Saccio, DGALA Secretary Pete Williams '76 and other alums and faculty presented an engaging program of reflections, awards and commentaries.

GSA co-chair Jamal Brown '08, a lead organizer of PRIDE week, gave opening remarks about the importance of LGBT history at Dartmouth and the progress that has been made, but Brown cautioned that more needs to be done in bridging gaps both in the LGBT community itself and between that community and allied communities at Dartmouth. Brown also noted the great contributions to the Week made by Raymond Rodriguez '09 (a DGALA/DCF Scholar), Dinah Warren '10 and Rigel Cable '10.

Pam Misener next reviewed the past year's significant events at Dartmouth, including Dartmouth being named to *The Advocate's* list of the 100 Best Colleges for LGBT students, and DGALA members raising \$110,000 through the Alumni Fund to support the DCF/DGALA Scholars Fund for LGBT students. Tim Andreadis '07 (Student Body President) and Amanda Rosenblum '07 continued the history of the past year with a report on the successful initiative to have

gender-neutral housing offered by Residential Life beginning in the fall.

Retiring Professor Peter Saccio gave a moving keynote address, in which he too reviewed the history and struggles of LGBT people at Dartmouth, beginning with his days as the first openly gay advisor to LGBT students in the mid-1980s, to the creation of the Carpenter Foundation in the '80s, when Dartmouth refused to accept contributions earmarked for LGBT student programming, to the coming out during his valedictorian address in 1990 of Michael Lowenthal '90, to a student sit-in in President Freedman's office in support of modifying Dartmouth's non-discrimination policy to include sexual orientation, to protests about the College's support of ROTC despite its violations of the amended non-discrimination policy, to the creation in the mid-1990s as a result of those protests of an administration position to advise LGBT students and to support programming for them. Saccio noted a common theme to these struggles and progress: "It's the students!" who have been responsible for them. Noting that struggles still remain to combat homophobia and to avoid a resurgence of AIDS, which devastated so many alumni, Saccio ended to a standing

Students Preview Documentary Film on Dartmouth LGBT Life and History

A highlight of the PRIDE week Dinner and Awards Ceremony at the Hanover Inn on May 11 was the premiere screening of an in-progress documentary film capturing, in the creators' words "the rich and diverse history of the LGBTQA community at Dartmouth." The film, whose current working title is "**PRIDE: a Documentary in Progress**," is primarily the work of Dinah Warren '10 and Rigel Cable '10, who are creating it as an informal independent study in connection with PRIDE. The film already includes interviews and other historical information provided by DGALA alums, and Dinah and Rigel plan to add substantial additional material to the film over the next year or more. Accordingly, they have asked *Green Light* to "please stress to alumni that we are looking for opportunities to listen to their experiences and to receive photographs or any other information they might have." In accepting his award, Amico honored the large group present, but also noted that a majority of LGBT students at Dartmouth remain in the closet and do not feel able to attend events like PRIDE. Indeed, Amico noted that students who are "out" in their college lives are making a sacrifice in the sense that closeted students who might like to know them do not feel comfortable interacting with out students, lest their "cover be blown." After receiving his award, Amico commented to *Green Light*, "I am deeply honored to be recognized by the LGBT community at Dartmouth. This award is a testament to the infinite number of ways that LGBT students can be activists on campus. Whether we are writers, artists, politicians, or something else entirely, our accomplishments and dedication to the community is equally appreciated."

Three graduating students were given the Ezekiel Webber '00 Award, named in honor of former DGALA director Zeke Webber. Michael Guzman '05 presented the award to Amanda Rosenblum '07, recognizing Amanda's work in bringing about gender neutral housing and in helping to unite lesbian voices on campus. Sarah Morton '05, a Webber award winner in her graduating year, presented the award to Green Light Shenen Wong '07, particularly noting Shenen's work with people of color. CAMPUS NOTES

Gender-Neutral Housing Coming to Campus! Openly gay student body president Tim Andreadis' campaign for the College to offer gender-neutral housing has succeeded, and the option will be available to students beginning this fall. In the words of the Office of Residential Life, "Gender neutral housing allows for same-gender, opposite-gender or other-gender identities to live together regardless of biological sex." Among the housing options will be a gender-neutral floor with programming on gender identity and expression in a supportive environment.

Admitted LGBTQA Students welcomed on campus! The Admissions Office "Dimensions of Dartmouth" program in April for admitted students offered several LGBTQA-friendly initiatives, including an LGBTQA hosting option (offered to both hosting students and visiting applicants), Queer Bar Night at the Lone Pine Tavern in the Collis Student Center and an open GSA meeting.
